PROMOTION TERMS AND CONDITIONS

1. This offer is available from 15/03/2026 – 31/05/2026 (herein the “Offer Period”).
2. This **VT Premiere League** cannot be used in conjunction with any other VT Markets promotions, including the Welcome Bonus and Deposit Bonus, unless otherwise stated.
3. This offer is open to all new clients, existing clients, clients under IB's (excluding all sub-IBs) of VT Markets. To be eligible, clients must have registered a live trading account, and traded with VT Markets, and reside in one of the eligible countries or regions specified below:
